This agreement is entered into on 06/01/2016 by and between

Party (hereinafter referred as 'NPRCET')

AND

Punnapatti Panchayat, Punnapatti Village, Natham, Dindigul – 624401 (hereinafter
referred to as 'Punnapatti Panchayat')

(First Party and Second Party are hereinafter jointly referred to as 'Parties' and individually as 'Party')

WHEREAS:

- A) First Party is a Higher Educational Institution named:
NPR College of Engineering & Technology
- B) First Party & Second Party believe that collaboration and co-operation between themselves will promote more effective use of each of their resources and provide each of them with enhanced opportunities.
- C) The Parties intent to co-operate and focus their efforts on co-operation within the area of waste management.
- D) Both Parties, being legal entities in themselves desire to sign this agreement for advancing their mutual interests.
- E) **Punnapatti Panchayat**, the Second Party is engaged in the fields of waste management.

NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS COLLABORATION AGREEMENT, THE PARTIES HERE TO AGREE AS FOLLOWS:

CO-OPERATION

- Both Parties are united by common interests and objectives. They shall establish channels of communication as well as co-operation that will promote and advance their respective operations within **NPRCET and Punnapatti Panchayat**. The Parties shall keep each other informed of the potential opportunities and shall share all information that may be relevant to secure additional opportunities for one another.
- The general terms of co-operation shall be governed by this collaborative agreement. The Parties shall cooperate with each other and shall, as promptly as is reasonably practical, enter into all relevant agreements, deeds and documents (the 'Definitive Documents') as may be required to give effect to the actions contemplated in terms of this agreement. The term of Definitive Documents shall be mutually decided between the Parties. Along with the Definitive Documents, this agreement shall represent the entire understanding as to the subject matter hereof and shall supersede any prior understanding between the Parties on the subject matter hereof.

SCOPE

- The Punnapatti Panchayat could play a key role in handling of waste management from institution. Both parties believe that close co-operation between the two would be of major benefit towards the green environment and clean campus.
- Punnapatti Panchayat and Institution interaction will give an insight into the self-awareness and public awareness for handling the waste management to maintain the green environment. The Second Party will provide necessary entry and exit permission included, but not restricted to gate pass, other access formalities to use its space for loading of recyclable and man power movement during the time of pickup.
- Both Parties have to obtain all internal approvals, consents, permissions and licenses of whatsoever nature required for offering the programmes on the terms specified herein.
- There is no financial commitment on the part of the NPRCET, the First Party to take up any programme mentioned in this agreement. If there is any financial consideration, it will be dealt separately.

VALIDITY

- This Agreement will be valid for **10 years** from the **06/01/2016** and it is expressly terminated by either Party on mutually agreed terms, during which period **Punnapatti Panchayat**, the Second Party, as the case may be, will take effective steps for implementation of this agreement.
- Both Parties may terminate this agreement upon 30 days 'advance notice in writing. In the event of termination, both parties have to discharge their obligations as agreed till the date of termination.


